- 1 Residential garbage can pick-up is weekly on Tuesdays.
- 2 Commercial dumpster pick-up is monthly on Monday, Wednesday or Friday.
- 3 Garbage cans should be spaced three feet apart on pick-up day if you have more than one.
- 4 NO hazardous waste to be disposed of in garbage cans or dumpsters, such as paint, oil, batteries, etc. Hazardous waste can be disposed of at the Duchesne County Bluebench Landfill.
- 5 Garbage cans should be removed from the street the same day as pick-up within 12 hours.
